## All-terrain vehicle routes ordinance.

STATE OF WISCONSIN Town of Hiles Wood County

### SECTION I - TITLE AND PURPOSE

The title of this ordinance is the Town of Hiles All-Terrain Vehicle Route Ordinance. The purpose of this ordinance is to establish all-terrain vehicle routes in the town and to regulate the operation of all-terrain vehicles in the town and shall supersede any other ordinance pertaining to same.

#### SECTION II - AUTHORITY

The Town Board of the Town of Hiles, Wood County, Wisconsin, has the specific authority to adopt this All-Terrain Vehicle Route Ordinance under  $\underline{s}$ . 23.33 (8) (b) and (11), Wis. stats.

### SECTION III - ADOPTION OF ORDINANCE

The Town Board of the Town of Hiles, Wood County, Wisconsin, by this ordinance, adopted on proper notice with a quorum and roll call vote by a majority of the town board present and voting, provides the authority for the town to designate all-terrain vehicle routes in the town and to regulate the use of those routes and all-terrain vehicles in the town.

### SECTION IV - OPERATION OF ALL-TERRAIN VEHICLES

Pursuant to <u>s. 23.33 (4) (d) 4.</u>, Wis. stats., except as otherwise provided in <u>s. 23.33 (4)</u>, Wis. stats., no person may operate an all-terrain vehicle on the roadway portion of any highway in the town except on roadways that are designated as all-terrain vehicle routes by this ordinance. Operation of all-terrain vehicles on a roadway in the town that is an all-terrain vehicle route is authorized only for the extreme right side of the roadway except that left turns may be made from any part of the roadway that is safe given prevailing conditions.

### SECTION V - DESIGNATION OF ALL-TERRAIN VEHICLE ROUTES

The following routes are designated all-terrain vehicle routes in the town:

- Hay Creek Road, from CTH V west to the Jackson County line
- Holst Road, from Hay Creek Road to termination
- Berry Road, from STH 54 to termination
- Wallace Road
- o Cary Hiles Road, from Turner Road west to Wolf Road
- Cranberry Road, from STH 54, 0.5 miles to the south

SECTION VI - CONDITIONS APPLICABLE TO ALL-TERRAIN VEHICLE ROUTES

Pursuant to <u>s. 23.33 (8) (d)</u>, Wis. stats., the following restrictions are placed on the use of the town all-terrain vehicle routes designated by this resolution:

Routes shall be marked with uniform all-terrain vehicle route signs in accordance with <u>s. NR 64.12 (7)</u>, Wisconsin Administrative Code. No person may do any of the following in regard to signs marking town all-terrain vehicle routes:

- 1. Intentionally remove, damage, deface, move, or obstruct any uniform all-terrain vehicle route or trail sign or standard or intentionally interfere with the effective operation of any uniform all-terrain vehicle route or trail sign or standards if the sign or standard is legally placed by the state, any municipality or any authorized individual.
- 2. Possess any uniform all-terrain vehicle route or trail sign or standard of the type established by the department for the warning, instruction or information of the public, unless he or she obtained the uniform allterrain vehicle route or trail sign or standard in a lawful manner. Possession of a uniform all-terrain vehicle route or trail sign or standard creates a rebuttable presumption of illegal possession.
- B. Operation shall be subject to all provisions of <u>s. 23.33</u>, Wis. stats., which is adopted as a part of this ordinance by reference, pursuant to s. 23.33 (11), Wis. stats.
- C. A copy of this ordinance shall be sent by the town clerk to the Wood County Sheriff's Department.
- D All ATV operators shall observe posted roadway speed limits. All ATV operators shall ride single file All ATV operators shall slow the vehicle to 10-mph or less when operating within 150 feet of a dwelling

The trails shall be closed during spring thaw cycle, to correspond with the road postings by the Wood County Highway Commission.

# The Town Board reserves the right to rescind this ordinance at any time at its discretion.

### **SECTION VII - ENFORCEMENT**

This ordinance may be enforced by any law enforcement officer authorized to enforce the laws of the state of Wisconsin.

### **SECTION VIII - PENALTIES**

The penalties under in <u>s. 23.33 (13) (a)</u>, Wis. Stats., are adopted by reference.

### **SECTION IX - SEVERABILITY**

If any provision of this ordinance or its application to any person or circumstance

is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end, the provisions of this ordinance are severable.

### **SECTION X - EFFECTIVE DATE**

This ordinance is effective on publication or posting.

The town clerk shall properly publish this ordinance as required under  $\underline{s}$ . 60.80, Wis. stats.
